#### MLK BRANCH REMODEL

Brewery Credit Union is committed to providing our members the fastest and most convenient member service experience. We're upgrading our main branch with more open spaces for your comfort and so you feel more at home. The first floor will have significant improvements to the teller line, member services area, offices, and lobby entrance. Our second floor will get interior and technology updates for the operations department, loan department, loan support, and our employee kitchen/lounge. Finally, the exterior of the building will have a new modern look. The remodeling project will be completed in four phases so Brewery Credit Union can remain open to serve our members. Such an endeavor will take several months to complete and of course, will have its challenges. The Board, management, and staff ask for your patience and to pardon our dust.

#### NEW BAYVIEW LOCATION

For almost 15 years, Brewery Credit Union found a home at the Outpost Natural Foods in Bayview. Outpost Natural Foods approached us with their need for additional space at their Bayview location. Upon evaluation of our branch, Brewery Credit Union has decided to find a new location to better serve our members and community. We will be moving from the Outpost Natural Foods to a new, larger location about a block south at 2863 S. Kinnickinnic Ave. While we do not have an official moving date yet, we anticipate the move will occur during the third quarter of this year. Our cooperative partnership with Outpost Natural Foods and our commitment to serving the Bayview community shall continue for years to come. We will also continue to offer the Outpost Natural Foods Credit Card, where 1% of every purchase goes back to Outpost to use for educational programming in our community.
